Mayor Duncan called the meeting to order. Marvin Neill offered prayer. Mayor Duncan led the chambers in the pledge of allegiance.

City Recorder Allison Baker called the roll: Mayor Duncan present, Vice Mayor Tinnin present, Commissioner Anderson present, Commissioner Bell present, and Commissioner Young present.

Consider minutes of the April 11, 2019 regular meeting of the Board of Commissioners. Vice Mayor Tinnin made a motion to approve the minutes as written. Commissioner Anderson seconded the motion and motion passed 5-0.

City Manager Tim Ellis announced that an Arbor Day Celebration will be held at 11:30am at Peay Park on Friday, April 26th and the Goodlettsville Ministerial Association will host the National Day of Prayer on May 2nd at 7:00am at City Hall. Sumner County Tax Assessor, John Isbell, will be at the Visitor's Center from 6:00pm-8:00pm on May 14th for anyone wanting to file an informal appeal. The deadline for the appeal is June 4th.

Consider Resolution 19-849, a resolution proclaiming April 26, 2019 as Arbor Day in the City of Goodlettsville. Commissioner Young made a motion to consider Resolution 19-849. Vice Mayor Tinnin seconded the motion. Vote was then taken which resulted in a 5-0 vote to approve Resolution 19-849.

Consider Resolution 19-850, a resolution declaring certain property surplus to the needs of the City of Goodlettsville and calling for its disposal by online auction or any other reasonable manner. ITEMS LISTED IN EXHIBIT "B" SHALL BE

DESTROYED IN ACCORDANCE TO TENNESSEE CODE ANNOTATED 53-11-451. ITEMS LISTED IN EXHIBIT "C" SHALL BE TRADED WITH A CLASS III REGULATED FIREARMS DEALER IN ORDER TO PURCHASE OTHER FIREARMS, AMMUNITION AND EQUIPMENT IN ACCORDANCE TO TENNESSEE CODE ANNOTATED 39-17-1317.

Commissioner Bell made a motion to consider Resolution 19-850. Commissioner Young seconded the motion. Vote was then taken which resulted in a 5-0 vote to approve Resolution 19-850.
